## ORDINANCE RELATING TO FEES FOR DATA PRACTICES ACT REQUESTS

The Board of Supervisors for the Town of Credit River, Scott County, Minnesota, does hereby ordain:

**Section 1:** Purpose: The purpose of this Ordinance is to establish certain fees for the delivery of services and processing of various requests for information as established by the Credit River Town Board to equitably allocate administrative costs to those generating the demand or utilizing the service under the Data Practices Act.

**Section 2:** Fee Schedule: The Credit River Town Board hereby establishes the following schedule of fees for Data Practices Act Requests:
