

Scott County Communities Will Try Untangling Merger Mess

MAZE OF COUNTER PROPOSALS

Attorneys for communities in northern Scott County seeking mergers and annexations are scheduled to meet in Shakopee Wednesday to untangle a growing maze of counter proposals that have developed.

So far, only one request for a merger of Savage Village and Glendale Township has remained unchanged since a series of petitions was filed before the Minnesota Municipal Commission late last year.

Originally, Prior Lake asked to annex 3 square miles at the southwest corner of Glendale Township, a square mile in Credit River Township, and 2 square miles in Eagle Creek Township, and all of the northern part of Spring Lake Township, about 11 square miles.

First, Prior Lake lopped off one section on Glendale Township. Prior Lake has fought vigorously to annex the remaining two sections along the western border of Glendale at the southwest corner of the township.

The two diagonal Glendale sections, also sought to be included in the Glendale-Savage merger, include the large northern tip of Prior Lake, 12 1/2 x 4 1/2 miles, and a body of water about 6 miles long including Spring Lake and all of the northern part of Prior Lake Village officials in the United States is the Public Health Service.

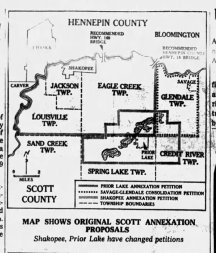
CROSSWORD PUZZLE
