#### 4 Open Forum

The public forum is intended to afford the public an opportunity to address concerns to the Council. The public forum will be no longer than 30 minutes in length and each presenter will have no more than five (5) minutes to speak. Topics of discussion are restricted to local governmental topics rather than private or political agendas. The Council may discuss but will not take formal action on public forum presentations.

- Dave Burnello: Asking for Transparency having the minutes and Sheriff Reports added to the website
- Geir Friisoe Vernon Ave. Concerned with the tax increase. This will be addressed in the Truth in Taxation presentation.
- Tim Conroy: Plowing concerned with the plowing now that we are city. The snow is getting packed down and the equipment is not getting the compacted snow.
- Bill Wehrmacher Lights are needed at the intersections on CR 27 and Creekwood.
   Lights were once in place and are gone after the work on CR27 was completed. Council advised the county is responsible for this project and has been responsible for the light in Creekwood. (165th, 167th and Creekwood)
- Tina Mischka: Asked for an update on the Tree Ordinance request by the Credit River Rural Alliance.

# 6.1 Fiscal Year 2023 Budget and Levy Truth in Taxation Presentation

Treasurer Hill reviewed the 2023 Preliminary Budget Levy and the process to date which started in June. The preliminary Levy is the highest it can go but can be reduced. The next step will be for the Council to adopt the final levy and budget at the December 19<sup>th</sup> Council meeting. The Truth in Taxation presentation is available on the Credit River website.

Preliminary Revenue Budget: \$3,513,687, of which \$2,683,347 is the Levy portion (76%)

Preliminary Expense Budget: \$4,116,194, which is a 1% increase from the expense budget from 2022.

Public Safety, which includes both Fire and Sheriff, had the largest expenditure increase in the 2023 proposed budget. Fire is contracted through Prior Lake and Sheriff Deputies through Scott County.

- Currently in 2022, the city has one full time deputy at 40 hours per week, The proposal in 2023 is to increase to 80 hours per week by adding an additional deputy.
- Interim City Administrator McNeill explained that Prior Lake, Credit River, and Spring Lake Township applied for the SAFER Grant which is a federal program used to address

staffing issues. Prior Lake Fire Department needs to hire full time fire fighters. Part time fire fighters are difficult to retain. A presentation is available on the Prior Lake website regarding the Prior Lake Fire proposal. SAFER Grant final notices of award are expected prior to the next meeting according to Rep Amy Craig. If successful it will cover three years of salary for the firefighters.

Treasurer Hill noted Credit River has the lowest Tax Capacity rate of cities in Scott County. The average tax increase is \$270.81 per year. The preliminary revenue budget includes states funds such as MSA funds and funds from a percentage of issued tickets such as speeding.

Mayor Kostik opened the meeting for public comments:

o Bill Markert: 7690 Cress View: If 35% of emergency calls are responded to by the Credit River Deputy and the remaining 65% are handled by the Scott County Sheriff on duty. Why is a second deputy needed?

Response time is not known at this time but can be requested.

- o Greir Fresso Vernon Ave Agree with fire, concern with the increase in the sheriff staff and if it is needed. Also does the city need a full-time administrator?
- Tina Mishca: Asked if the Full-Time City Administrator was budgeted in? Was the Recruiting firm budgeted in?

Both were budgeted into the 2023 budget.

- Ron Sackett Wants to better understand state aid and grants.
   Mayor Kostik- Municipal State aid (MSA) for roads received. Interim City Administrator McNeill Generally state aid is no longer received by cities. Treasurer Hill explained MSA funds and funds from tickets/fines are included in the budget.
- Council comments on fire contract: The Credit River portion of the fire expense is at actual cost which is approximately 18% of the Prior Lake total based on the current contract. There are often times that four firefighters are not available with a part time staff.
- Council comments on Sheriff Elko New Market has a full Police Department Chief and six police officers costing approximately \$1 million, and they have 1,000 less in population than Credit River. Since Credit River contracts with Scott County, they are responsible for hiring, staffing and equipment.
- O Denise Peterson –8030 165th St E. Can the Sheriff's contract be done similar to the Fire department or sharing Deputy with other communities, etc.?
- Art Stonebridge. They received a tax increase of 49%. The council needs to ask what expenses are needed, discretionary vs non-discretionary expenses.

- o If we had not become a city what would the taxes be today? Council stated the Fire and Sheriff deputies are the main increase and would have been added anyway. The City Administrator position will be new. Interim City Administrator McNeill explained Credit River does not have a Public Works Department, the council is very hands on more so than elected officials normally are in a city.
- o Tina Taylor Rolling Oaks Court. Are property values increased so that taxes can be increased? Council advised a notice will be sent out with taxes regarding valuation. Local Board of Adjustment and Equalization (LBAE) occurs in April, and it is recommended to have your property reviewed and re-evaluated if residents disagree with the valuation.

Hearing no further comments, a request to close the Truth in Taxation Hearing was requested.
