WHEREAS, it appears that Prior Lake Blacktop is the lowest responsible bidder at \$218,837.90.


**NOW THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF CREDIT

WHEREAS, it appears that McNamara Contracting is the lowest responsible bidder at \$474,003.18.


