SERVICE FEES AND RELATED INTEREST - TERRITORY**


WHEREAS, pursuant to proper notice duly given as required by law, the Township of Credit River has met and heard and passed upon all objections to the proposed certification for unpaid sewer charges and delinquent administrative enforcement fines, attorneys fees and interest;

NOW, THEREFORE, the Town Board of Credit River Township, Scott County, Minnesota, pursuant to Minnesota Statute Section 366.012, hereby orders the following amounts certified to property taxes as identified on attached Exhibit A.

Each such certification as identified on attached Exhibit A shall be payable in one lump sum and shall bear interest at the rate of Six Percent (6%) per annum from the date of adoption of this Resolution. To the lump sum payment shall be added interest on the entire certification from the date of this Resolution until December 31, 2018.

The Credit River Township Treasurer shall forthwith transmit a certified duplicate of this Resolution to the County Auditor to be extended on the proper tax lists of the County and such assessment shall be collected and paid over in the same manner as other municipal taxes.
