**RESOLUTION APPROVING TRANSFER OF FUNDS FOR REIMBURSEMENT  
OF WAGONWHEEL TRAIL, CANTER LANE, CORRAL CIRCLE,  
BOULDER CREEK DRIVE AND 219<sup>TH</sup> STREET EAST, CREEKWOOD  
CIRCLE, CREEKWOOD ROAD, CREEKWOOD LANE AND  
CREEKWOOD DRIVE, HARVEST HILLS DRIVE AND CENTURY LANE  
EXPENSES**

**WHEREAS**, Credit River Township desires to reimburse itself with bond proceeds for expenses paid from the Capital Improvements Fund (Fund 401) for Wagonwheel Trail, Canter Lane, Corral Circle, Boulder Creek Drive and 219<sup>th</sup> Street East, Creekwood Circle, Creekwood Road, Creekwood Lane and Creekwood Drive, Harvest Hills Drive and Century Lane

**WHEREAS**, Credit River Township passed a Reimbursement Resolution on Febuary 12, 2018 for Wagonwheel Trail, Canter Lane, Corral Circle, Boulder Creek Drive and 219<sup>th</sup> Street East, Creekwood Circle, Creekwood Road, Creekwood Lane and Creekwood Drive, Harvest Hills Drive and Century Lane allowing for the reimbursement of expenses paid; and

**WHEREAS**, the total expenses to be reimbursed is \$125,063.62, with the amounts paid in each year per road project as follows:



**NOW THEREFORE, BE IT RESOLVED** by the Town Board of Credit River Township to direct the Township Treasurer to transfer funds as follows:


1. Transfer \$5,880.46 from the 2018 Road Projects Fund (Fund 430) to the Capital Improvement Fund (Fund 401) for 2017 expenses paid;

2. Transfer \$119,183.16 from the 2018 Road Projects Fund (Fund 430) to the Capital Improvement Fund (Fund 401) for 2018 expenses paid.
